Acknowledge that a horse may, without warning or any apparent cause, buck, stumble, fall, bite, kick, run, make unpredictable movements, spook, jump obstacles, step on a persons feet or body, push or shove a person, strike with either its front or hind legs, and saddle, bridle any other equipment that may loosen and/or break- all of which may cause the rider to fall, be jolted become seriously injured or killed.
2. Acknowledge that horseback riding and any other activity that takes place around horses is a dangerous activity and involves RISKS that may cause SERIOUS INJURY and DEATH because of the unpredictable nature and irrational behavior of horses regardless of their training, size, age and past performance.
3. Voluntarily assume the risk and danger of injury or death inherent to in the use or presence of horses, equipment.
4. RELEASE DISCHARGE AND PROMISE NOT TO BRING any claim, cause of action and/or lawsuit against GORILLA INVESTMENTS, INC and/or its employees, agents, directors, stockholders, affiliates, contractors, lessors, property owners and any other person or entity associated with GORILLA INVESTMENTS, INC.
5. Release the Releasees from any claim, action, and/or cause of action that such Releasees are, or may be, negligent in connection with my or my minor child's riding experience or ability including but not limited to training.
